1. Will there be a separate PTO for FPVA? **During FPVA's first year, we will find a volunteer "virtual parent representative" who can attend regular PTO meetings either live or virtually. The virtual representative will share important information with other FPVA parents on the FPVA Parent Community on Canvas**
2. What should be included in a Canvas "Parent Portal" where FPVA parents can connect and find answers to their questions? **We will include:**
 - a. **The FPVA Parent/Student Handbook,**
 - b. **The Learning Coach Guide,**
 - c. **Virtual Learning Resources from Edgenuity and other places divided by grade and subject,**
 - d. **Celebrations of the good things happening at FPA and FPVA,**
 - e. **A monitored Chat and Discussion areas for Q&A,**
 - f. **Contact and Directory information,**
 - g. **Announcements and Calendar information**
 - h. **State Assessment Information**
 - i. **Forms for Scheduling/Fee Waivers**
 - j. **Links to our FPA Websites**
3. When FPVA students come to our school buildings to test, will they be required to follow the dress code? **Anytime FPVA students join FPA student at an activity where the dress code is required, FPVA students will also need to be in school uniform as outlined in our dress code policy.**
4. When FPVA students attend field trips, will they be required to follow the dress code? **Same as #3**
5. What will be the procedure for if a student "gets ahead" of their grade level in FPVA and then wants to transfer back to FPA 1, 2 or 3? **A placement test to confirm readiness for a higher level will be administered and students will be placed accordingly.**

6. What will happen if an FPVA student finishes the term or school year early? **Because these situations are more rare than common, we will consider these situations case by case.**
7. Are FPVA parents required to fulfill the 40 hours of family service? **No, for FPVA's first year, the focus will be on supporting parents as Learning Coaches.**
8. What will happen with online students that have IEP's, 504 plans or ELL accommodations? **The FPA Sped department will work with these students to meet all IEP, 504, or ELL needs.**
9. Will virtual high-school students still receive an iPad? **Yes**
10. How will families far from Freedom participate in the FPVA orientation and receive material needed? **All FPVA families will be invited to attend a live orientation on Aug10th at 6:30pm and will receive needed materials at that time. For those who cannot attend the orientation information will be recorded and materials will be sent via mail or other arrangements.**
11. **What is our deadline for enrollment in FPVA? Aug. 5th is the deadline for FPVA enrollment to give our principals time to adjust/hire new teachers if need be, and send information out to all parents on the 7th with on-site class assignments. Dec. 1st is the deadline for requests to switch either into or out of FPVA.**
