4. Approve Early Graduation Requests

Amanda Gabbitas introduced two students who are requesting early graduation: Hope Adams and Korbin Aagard. Both Hope and Korbin presented their early graduation plans as well as their post-graduation plans. Both students are hoping to graduate May 23, 2024, with the rest of the class of 2024.

Paul Baltes moved to allow Hope Adams and Korbin Aagard to graduate early. Cary McConnell seconded. 3-0 passed, no opposition.

5. Report on Accelerated Student Learning Grant

Karla Kay Snow explained that the Accelerated Student Learning Grant funds Honors and AP classes at the secondary campus and the Gifted and Talented Program at the elementary campuses. With the elementary portion, she is required to report to the Governing Board on the fund usage and goals. Some highlights of her report explained goals of the program and where funding will be utilized. Funding goes toward purchasing supporting software and teacher stipends. Goals include focusing on raising the number of socio-economically disadvantaged students as well as the number of female students entering GATE. Other goals include exposing all students to GATE experiences using a digital platform as assistance and launching the GATE program at the St. George campus.

Paul Baltes asked about self/parent GATE qualifying testing as well as discussed possible reasons for the gender discrepancies.

This grant is renewed yearly.

6. Approve LEA Specific License for Nine Teachers
