Cary McConnell moved to continue agenda items 2,4, and 5 to the October 12th, 2023, Governing Board Meeting, and moved agenda item 7 to be presented first.

7. Approve Revised FPA SPED Policy

Daniela Alvarez, FPA SPED Director, reviewed the proposed revisions to the FPA SPED Policy.

The Utah Legislature approved changes in their last session; therefore, all schools must adopt these changes. The process for adopting them is to acquire USBE SPED Dept. approval on the new manual first (which has been done) and then to get approval from the governing board. Therefore, FPA's new SPED Policy has already been approved by the state. Daniela explained the minor changes to the Policy which are mostly for clarity.

SPED spacing needs were briefly discussed and Cary McConnell asked how often the SPED Policy is updated (annually).

Jay Garlock moved to approve the revised FPA SPED Policy as presented, including the changes required by the Utah Legislature.

Thomas Chan seconded. 3-0 passed, no opposition; Paul Baltes absent.

Chris Helvey reminded the board that there will be a SPED audit in February.

SPED expansion and soccer field completion at FPA2 will be included in this RFP. Chris Helvey reviewed FPA2 building layout with the board and described the proposed SPED addition.

Note: These expansions will not require approval from USBE.

Thomas Chan expressed concern that the students will lose space they currently use for socializing. Chris Helvey pointed out that details/concerns can be discussed in more detail in a future phase of the project.

Thomas Chan and Cary McConnell will review the RFP for the expansion projects.

Cary McConnell reminded the board that reviewing the budget is a standing agenda item.
